COMPANION AGREEMENT

Updated 16 May 2007

The Abundant Garden Management and family thanks you for reading this Agreement. Abundant Garden has been set up in a company structure and therefore we are required to follow Australian and New Zealand Laws.

As a Companion in the Abundant Garden I agree to:

1. Always stand in my integrity, work from my heart and speak my truth.
2. Help others become aware of the beauty of Life, to know that all Life is Sacred, not just the meals.
3. Embrace the opportunity to honour Abundant Garden and all those associated with Abundant Garden.
4. Abide by the decisions made by Abundant Garden Management both now and in the future.

As a Companion I Confirm That:

1. I have seen the Companion Planning Phi-nancial Opportunity and I understand that:
 - I will purchase a minimum monthly order of 3 bags of Sacred Meals, and I can add more if I wish.
 - I will activate an auto payment for either the 6th or 24th of each month to cover my monthly order.
 - I will choose a dispatch date for my order from either the 11th or 29th of each month.
 - If I require a product refund, I know to claim this within 7 days of the receipt of my goods. I understand the freight costs will be covered by me – the Companion unless the reason is to do with the quality of the products, then Abundant Garden Management will pay the freight costs and refund the cost of the product.
 - I accept that all products are properly packaged before they leave Abundant Gardens' warehouse and I am responsible for checking the condition of the delivered goods. Any products damaged in transit or upon delivery are the responsibility of the Deliverer. I am responsible for notifying the Deliverer and Abundant Garden Management.
 - I am eligible to receive "thank you" rewards as defined by the Companion Planning System, each time I fulfill my monthly order.
 - I understand that the "Thank You" will be paid by Abundant Garden Management on the 10th of each month for all orders received and cleared up to and including the last day of the previous month.
 - If I do not qualify, any commissions on my account will move upline for that month.
2. I embrace and accept responsibility for my role as a Companion
3. I am a human being and over 18 years of age.
4. I can personally activate and maintain only one Companion position at any time.
5. I am responsible for paying all my own expenses including government taxes.
6. I understand that all my information will be kept private and confidential and will not be shared, traded to any other source other than is legally required.
7. I understand that companion and customer lists and names are the property of Abundant Garden Management. I will never use these for any commercial or business purpose without prior written consent from the Abundant Garden Management.
8. I abide by Australia and New Zealand laws in all aspects and place special note in regards to new anti spamming and faxing regulations.

9. All recipes, names, formulations are to be honored and I understand that they are the intellectual property of the founder of Abundant Garden which by law carries the copyright protection.
10. I understand that all products produced by Abundant Garden are only to be sold in the original designed packaging and at the prices set. I am not to sell Sacred meals as individual balls.
11. I understand that the laws of both New Zealand and Australia state that Abundant Garden may not make any therapeutic or medical claims that our products may seem to have. I understand that if I make such claims I am responsible for my own actions and I will be asked to leave the Abundant Garden.
12. I can share verified testimonials signed by the person sharing their experience and confirmed by Abundant Garden Management.
13. I understand that the Abundant Garden logos, designs and promotional materials are for the exclusive use of and are copyright to Abundant Garden Management. If I wish to use these logos I will require written permission from Abundant Garden Management.
14. I will direct any media enquiries to the Abundant Garden Management.
15. I am responsible for my personal actions both verbal and written or advertised, if different from those published and promoted by Abundant Garden.
16. I fully understand the agreement I have made with Abundant Garden Management. If I renege on this agreement made in good faith at this time I will personally bear any costs or expenses incurred by my actions or activities.
17. I will honour the commitment I am making to the Abundant Garden and indemnify Abundant Garden, against all action, proceeding, liabilities, claims, damages, costs and expenses arising from my actions.
18. I understand that Abundant Garden Management can cancel my membership if I do not fulfill my commitment to this agreement.
19. If I resign I surrender my position and any links to any companions that may have been generated by my efforts to the Abundant Garden Management.
20. If I leave this world I understand I may leave my Companion Planning Phi-nancial Opportunity to any one whom I have nominated. A copy of this agreement will be available to my nominee who will have a period of 6 months to confirm a Companion Agreement.
21. I understand that Abundant Garden Management can update this Agreement at any time. Each update will become the current replacing all previous. All updates will be available.
22. I have read and fully understand this Abundant Garden Companion Agreement.
